All member Federations **MUST** submit their 'Intention to Enter' for the **2021 IWWF EUROPE OPEN & DISABLED WATERSKI CHAMPIONSHIP** through the online Admin system at: <https://www.waterskieurope.com/intention-to-enter/> by **23-May-21** using the password which was provided to your Federation for this purpose.

For all Europe & Africa Titled Events, the EC Waterski Council will publish an 'Intention to Enter' form to the Federations on <https://www.waterskieurope.com/intention-to-enter/>. This form has to be returned to the Organizer and to the EC representative to the event with a deadline of two months before the start of the competition by **23-May-21**.

For late submission of the 'Intention to Enter' form a penalty of **200,00€** will be applied in accordance with E&A Additional Rules 14.12

To be accepted, the 'Intention to Enter' form must be accompanied by a deposit of 50,00€ for each athlete mentioned on the form. (For instance: 3 athletes: 3x50,00 € = 150,00 €). This payment will ensure the number of riders participating at the event is accurate and enable the planning of the event.

The payment receipt number must be entered on the form at the time of submission.

This amount is non-refundable. This 50,00 € will be deducted from the entry fee to be paid for each athlete. The Federation may enter up to two additional athletes more than originally declared on the 'Intention to Enter' form. If more than two additional athletes participate, then a fee of 50,00 € per additional athlete will be levied upon that Federation.

Don't forget to request for Familiarization time on the official 'Intention to Enter' form along with the number of skiers in each event requiring time.



7. OFFICIAL FAMILIARIZATION

E&A Tournament Additional Rule 14.07 (Replaces IWWF rule 14.07)

The last two or three days immediately before the Championships will be reserved and used for Official Familiarization. This will be organized so that each competitor who has paid shall be allocated either a set number of passes and/or a certain amount of time at the discretion of the Chief Judge, based on the principle that every skier shall receive an equal opportunity for familiarization.

For Disabled skiers, official familiarisation will be offered with the same conditions and process (registration, rates, time, e.t.c) as for waterski athletes. (Waterski Additional rule 14.07)

Slalom skiers will receive – 4 passes or 6 minutes whichever is less
Tricks skiers will receive – 2 passes or 5 minutes whichever is less
Jump skiers will receive – 3 passes or 6 minutes whichever is less

Each team requesting familiarization time shall indicate it on the official 'Intention to Enter' form, which must be submitted at least 60 days before the scheduled start of the event. They must indicate how many skiers in each event wish to participate. Teams who do not comply with this deadline will not be included in the familiarization schedule.

At least 45 days before the scheduled start of the event, the Organizer, in consultation with the Chief Judge, whose decision shall be final, shall announce the official familiarization schedule (including the allowed time). Time will be scheduled for competitors on a random team basis, and shall be grouped by event, i.e. slalom familiarization, trick familiarization and jump familiarization (by jump height) will be grouped together.

Any athlete whose time has not been paid for at least 30 days before the scheduled start of the event, or who is not ready to ski in accordance with the schedule, will lose their official familiarization time.

45 days before	07-june-21	Deadline for publishing familiarization schedule by Organizer
30 days before	22-june-21	Deadline for familiarization payment. Slot will be confirmed through payment.

The Chief Judge shall have the discretion to change the start time of team's familiarization based on extraordinary circumstances.

The Organizer may offer additional training during any unallocated times.
The maximum cost per hour for Official Familiarization will be € 240,00 (€ 4,00 per minute).

Anyone will be able to book any time remaining available with the organizer directly.

For late submission of the Entry Forms a penalty of 10,00€ per skier per day will be applied in accordance with E&A Additional Rules 14.12.

Late entries will only be accepted with the mutual consent of the Organizer and the Chief Judge.

The Entry Fee per competitor, regardless of the number of disciplines, is **180,00 €**

Payment: Must be done through IWWF Event Management System (EMS)

Please Note: Bye-Law 4.5.1.6

The entry fees of teams or individual athletes failing to show an entry form has been submitted by their Federation shall still be payable in full, unless a valid written excuse is received by 12 noon of the day before the start of the competition. The Chief Judge shall decide whether or not the excuse is valid.

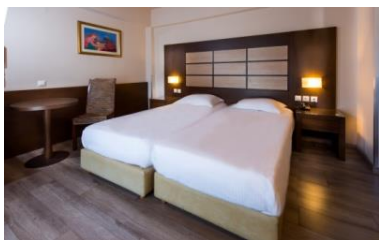

18. TRANSPORTATION

It is the responsibility of each team to arrange their own transportation to the site and between the site and their chosen hotel for each day of the competition.

If the team is unable to do this, then the organizer will endeavor to make the necessary arrangements at a cost.

We have negotiated a discounted rate with the car rental company "Hertz" which can be accessed with the code Euro21. All major car rental companies are located in Greece.

19. PARKING AND SKI STORAGE

The organization will supply storage for competitors' equipment.

While security staff will be on site, the organization is not responsible for equipment that is lost or damaged.

20. HOW TO ENTER THE COUNTRY

A valid Identity Card or Passport is required to enter Greece. All non-Schengen countries residents should contact the Hellenic Embassy or Consulate in their country, for more information on entering Greece. Any and all information provided and/or disclosed by, or on behalf of, myself to the IWWF and the Hellenic Waterski Federation (including any directors, officers, employees, volunteer and other representatives thereof) for the purpose of considering and evaluating my application for participation and competition in the Championships is true, correct and accurate;

I have fully read and understood the rules and regulations of participation and competition in the Championships (a copy of which has been made available to me) and I do hereby covenant with, and undertake to, the IWWF and the Hellenic Waterski Federation to at all times fully comply with and abide by, the same;

I am in good physical and mental health and I am physical capable of competing and participating, and fully competent to participate and compete, as a competitor in the Championships and that I have not been certified and/or advised otherwise by any qualified medical practitioner;

I do hereby authorize any and all physicians, paramedics and other medical personnel and practitioners procured by, or on behalf of, the IWWF and the Hellenic Waterski Federation to administer first aid treatment, or any medical treatment, surgery or transportation in the event of any illness, accident or injury suffered and/or sustained by me at any time during my participation and competition in the Championships (or any part thereof) and hereby indemnify, and shall keep fully and effectively indemnified, the IWWF and the Hellenic Waterski Federation (including all directors, officers, employees, volunteer and other representatives thereof) upon demand from and against any and all claims, liabilities, demands, costs and expenses of whatsoever nature incurred and/or suffered by the same (or any of them) and arising from, and/or in connection with, the procurement and administration of such medical treatment and transportation in relation to any such illness accident or injury suffered and/or sustained by me;

I acknowledge, agree and confirm that participating and/or competing as a competitor in the Championships (or any part thereof) involves inherent risks and dangers of accidents, personal and bodily injury and property loss or damage and that by signing and completing this Declaration, Waiver and Release Form, I fully understand and have considered and evaluated the nature, scope and extent of the risks involved, and voluntarily and freely choose to assume these risks;

I hereby grant to the IWWF and the Hellenic Waterski Federation (including its lawful successors and assigns) the sole and exclusive right and license, in perpetuity and throughout the world and without any compensation whatsoever to me, to use, reproduce, publish and/or exploit, my name, nickname, likeness, image, logos, get-ups, initials, voice, slogan and signatures developed from time to time, reputation, graphical representation, electronic, animated or computer generated representation and any other representation (in any medium whatsoever) right of association, biographical information and other indicia and any other right of property in my performances, in any media whatsoever, for any purposes whatsoever relating to, and/or in connection with, the IWWF and/or the Championships (or any part thereof) and I shall do all such things (including, without limitation, the execution of appropriate legal documentation) as the IWWF and the Hellenic Waterski Federation may, from time to time, require to give legal and binding effect to the aforementioned grant of rights;

1. I acknowledge that I am bound by, and confirm that I shall comply with, all of the provisions of the IWWF Anti-Doping Rules (as amended from time to time), the World Anti-Doping Code (the "Code") and the International Standards issued by the World Anti-Doping Agency, as amended from time to time, and published on WADA's website.
2. I consent and agree to the creation of my profile in the WADA Doping Control Clearing House ("ADAMS"), as requested under the Code to which IWWF is a Signatory, and/or any other authorized National Anti-Doping Organization's similar system for the sharing of information, and to the entry in my Doping Control, Whereabouts and Therapeutic Use Exemptions related data in such systems.
3. I agree that during the Event and for up to ninety (90) days thereafter as may be needed for follow up testing, I will be subject to blood and/or urine testing for any substance or method on the World Anti-Doping Agency ("WADA") Prohibited List: https://www.wada-ama.org/sites/default/files/resources/files/2021list_en.pdf
4. I acknowledge the authority of IWWF [and its member National Federations and/or National Anti-Doping Organizations] under the IWWF Anti-Doping Rules to enforce, to manage results under, and to impose sanctions in accordance with the IWWF Anti-Doping Rules.
5. I acknowledge and agree that any dispute arising out of a decision made pursuant to the IWWF Anti-Doping Rules, after exhaustion of the process expressly provided for in the IWWF Anti-Doping Rules, may be appealed exclusively as provided in Article [13] of the IWWF Anti-Doping Rules to an appellate body for final and binding arbitration, which in the case of International-Level Athletes is the Court of Arbitration for Sport (CAS).
6. I acknowledge and agree that the decisions of the arbitral appellate body referenced above shall be final and enforceable, and that I will not bring any claim, arbitration, lawsuit or litigation in any other court or tribunal.
